Thank you to everyone for continuing this cherished tradition and in helping families to continue to create lasting memories.

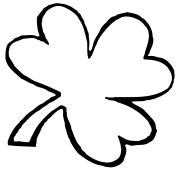

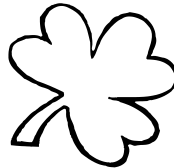
