## *Glen Burnie Carnival*

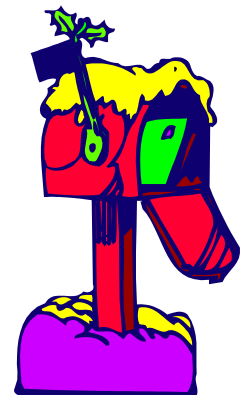

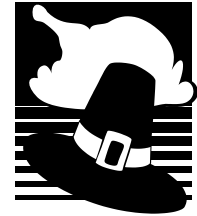
